- 1890 Annual Town Report: Arscott Blight owns a dwelling (\$600) [61 Oakland Street], a dwelling (unfinished, \$250) [6 Oakland Circle], and 1¼ acres of land on Oakland Street (\$450).
- 1891 Annual Town Report: Arscott Blight owns a dwelling (\$600), a dwelling (\$600), a dwelling (\$700), a dwelling (\$700), 1<sup>1</sup>/<sub>4</sub> acres [*sic* 2 <sup>1</sup>/<sub>4</sub> *acres*] of land on Oakland Street (\$600), and <sup>1</sup>/<sub>4</sub> acre of land off Forest Street (\$250).
- Arscott Blight built five houses on Oakland Circle between 1891 and 1896: #10, #14, #15, #23, and one on the site of 19 Oakland Circle (razed). All were of similar size and assessment therefore identifying the precise year of construction for each is impossible. The year built date of 1891 is an approximation.
