- 1871 Needham Town Report: Anna M. Torrey owns a dwelling (unf., \$5000) [25 Bird Hill Avenue] and 2 ¾ acres of improved land (Bird, \$1000).
- 1872 Needham Town Report: Anna M. Torrey owns a dwelling (\$8000) [25 Bird Hill Avenue] and 2 ¾ acre of improved land (Bird, \$1800).
- 1873 Needham Town Report: Anna M. Torrey owns a dwelling (\$7500) [25 Bird Hill Avenue], a barn (\$1800) [15 Bird Hill Avenue], and 2 3/4 acre of improved land (\$1800).
- Mortgage for \$7500 given by Anna M. Torrey to the Suffolk Savings Bank on August 25, 1871.
- Date of construction for dwelling at 25 Bird Hill Avenue determined to be 1871. Although 1872 assessments do not indicate that construction of the carriage house [now 15 Bird Hill Avenue] had begun by spring of 1872, it is likely that it was built later that year.
