- 1913 Annual Town Report: Annie Crawford not listed.
- 1914 Annual Town Report: Annie E. Crawford (non-resident) owns a dwelling (Farrington, \$600), and land (Lot 10, Block D, \$200).
- 1915 Annual Town Report: Annie E. Crawford (non-resident) owns a dwelling (Farrington, \$500) and 2370 sq. ft. of land (Lot 10, Block D, \$200).
- 1916 Annual Town Report: Annie E. Crawford (non-resident) owns a dwelling (Farrington, \$500) and 2370 sq. ft. of land (Lot 10, Block D, \$100).
- Building permit (listed under 10 Oak Avenue [former name of Stonecleve Road]): Owner is Annie Crawford of Melrose. Architect is not listed. Builder is J.A. Crawford of Melrose. Granted on November 10, 1913. Summer house. Estimated cost is \$900.
- Although assessments/permit indicate that the land was conveyed in 1913, deeds do not indicate that ownership of the land was transferred until December 27, 1915, two years after the house was constructed.
