## **Additional Information**:

- 1868 Needham Town Report: Elcy P. McIntosh (wife of Sylvester McIntosh) owns a dwelling and barn (387 Linden Street, \$1750), 3 ½ acres of improved land (\$575), dwelling (\$800), ½ acre of improved land (\$100), a dwelling (\$550), ¼ acre of improved land (\$50), a large, new dwelling (395-397 Linden Street, \$2200), and a shop (\$400). [This is the earliest record of 395 & 397 Linden Street.]
- 1878 Needham Town Report lists a two-family dwelling under ownership of Sylvester McIntosh. The 1879 Needham Town Report lists in the two-family dwelling's place two "tenement" dwellings. It is believed that Sylvester McIntosh divided the two-family dwelling into two separate, smaller dwellings in either late 1878 or early 1879. An article on Sylvester McIntosh in the June 20, 1974 issue of the *Wellesley Townsman* (that was written from interviews with descendants of the McIntoshes) reports that the physical separation of the two-family house was the result of a family discord.
