- No significant changes in 1914 & 1915 Annual Town Reports.
- 1916 Annual Town Report: Frank W. Connors owns (among other holdings) a dwelling on Atwood Street (\$1500) [11 Sessions Street], a shop (\$1000) [40 Atwood Street prior to conversion into dwelling], a dwelling on Sessions Street (\$3000) [9 Sessions Street], and land on Atwood and Sessions Streets (\$800).
- 1917 Annual Town Report: Frank W. Connors owns (among other holdings) a house (\$3200) [11 Sessions Street], a shop on Atwood Street (\$1000) [40 Atwood Street prior to conversion into dwelling], a house on Sessions Street (\$3200) [9 Sessions Street], and 16,000 sq. ft. of land on Atwood and Sessions Streets (\$800).
- No significant changes in 1918, 1919 & 1920 Annual Town Reports.
- 1921 Annual Town Report: Frank W. Connors owns (among other holdings) 4791 sq. ft. of land on Sessions and Atwood Streets (\$250). Grace Taylor owns a house on Sessions Street (\$3500) [11 Sessions Street], a shop (\$1500) [40 Atwood Street prior to conversion into dwelling], and 6202 sq. ft. of land (\$300). Helen B. Sibley owns a house on Sessions Street (\$3500) [9 Sessions Street] and 5018 sq. ft. of land (\$250).
- A mortgage for \$1800 was given by Frank W. Connors to the West Newton Savings Bank on June 29, 1915 (for site of 9 Sessions Street).

- Building permit for new dwelling (issued on July 10, 1922) listed under 9 Sessions Street at Wellesley Building Department is actually for the construction of 5 Sessions Street. In addition, no building permit for new dwelling listed under 11 Sessions Street.
- There are three relevant building permits listed under 40 Atwood Street:
 - o The first was issued on March 22, 1915 for a new dwelling estimated to cost \$3000. Owner is Frank Connors of Wellesley. Architect and builder is C.E. Stata of Newton Lower Falls. [This is believed to be 9 Sessions Street.]
 - The second was issued on March 31, 1915 for a new shop with dwelling intentions costing \$600. Owner and architect is Frank W. Connors of Wellesley. No builder given. [It is believed that this shop was never built and was replaced by third permit below 1
 - o The third was issued on May 15, 1915 for a new shop costing \$1000. Owner and architect is F. Connors. Builder is C.E. Stata of Newton Lower Falls. [This is believed to be 40 Atwood Street, which was converted from a shop to a dwelling in 1927 or 1928.]
