Hagar and Barbara Brehaut conveyed their interests in the southern parcel (8805 sq. ft.) to Willard S. McFayden. Each grantee was therefore the sole owner of his or her parcel. In 1933, Willard sold the southern parcel to Clarence S. Brehaut (son and heir of Barbara Brehaut), resulting in the single ownership of both parcels.
