- 1890 Annual Town Report (as of May 1, 1890): W.C. Norcross owns a dwelling (\$3300) [135 Washington Street], a dwelling (\$5300) [129 Washington Street], a barn (\$500), and 4 acres of land on Washington Street (\$3200).
- Helen M. Norcross (wife of William C. Norcross) sold 135 Washington Street on 2-acre lot to Emily Norcross (her sister-in-law) on March 1, 1890, suggesting that 129 Washington Street was completed in early 1890 rather than late 1889.
- No mortgage given by Helen M. Norcross for the construction of 129 Washington Street.
