- 1913 Annual Town Report: John N. & George E. Seagrave own 231,970 sq. ft. of land off Curve Street (\$10,057). George E. Seagrave owns a dwelling on Central Street (\$800) and 6098 sq. ft. of land on Central Street (\$900).
- 1914 Annual Town Report: John N. & George E. Seagrave own 207,879 sq. ft. of land off Curve Street (\$10,050). George E. Seagrave owns a dwelling on Central Street (\$800) and 6098 sq. ft. of land on Central Street (\$900), a dwelling on Summit Road (\$4500) and 24,091 sq. ft. of land on Summit Road (\$1000).
- "Ground was broken this week for a new house on Summit Road, the property of Seagrave Brothers, to be occupied by the family of Rev. Charles H. Daniels." Wellesley Townsman: June 20, 1913
- "The Rev. C.H. Daniels and family, who have resided on Atwood Street for several years, are now occupying the new home recently built for them on Summit Road." Wellesley Townsman: November 14, 1913
- Rev. Charles Herbert Daniels, D.D. died from an attack of aphasia on August 3, 1914.
- "TO RENT -- furnished or unfurnished, the attractive new house on Summit Road, opposite Harvard Street, from September 15, or thereabouts to the end of June 1916. The house has 9 rooms and a sleeping porch and every convenience for comfort. Absence of the family for a year makes this a special opportunity for a family wishing to live in Wellesley while a daughter attends the College." Wellesley Townsman: May 21, 1915
- "The house owned by Mr. George E. Seagrave on Summit Road, will be occupied for a year, from August 16, by Frank Ellsworth Allard M.D., and family of Boston. Mrs. Charles H. Daniel [*sic*] who has occupied the house will spend the year in New York City, where she intends taking some courses of study at Union Theological Seminary." Wellesley Townsman: August 13, 1915
