- 1913 Annual Town Report: Mahar & Poltier not listed. Mary R. Munier of Boston owns no dwellings but many lots of land including Lots 67 & 68 (of 6298 sq. ft. and 6684 sq. ft. worth \$125 each).
- 1914 Annual Town Report: Agnes Williams not listed. John Munier McIntosh et al own a dwelling on Boulevard Road (\$500) and many lots of land including 6298 sq. ft. of land on Riverdale Road (Lot 67, \$200). Simon Mahar and Joseph Poltier [sic] (of Malden) own a dwelling on Riverdale Road (\$1000) [*39 Riverdale Road under construction*] and 6684 sq. ft. of land on Riverdale Road (Lot 68, \$225).
- 1915 Annual Town Report: Agnes Williams lives on Riverdale Road and owns a dwelling on Riverdale Road (\$3500), 6298 sq. ft. of land on Riverdale Road (Lot 67, \$200), and 6684 sq. ft. of land on Riverdale Road (Lot 68, \$200). Mahar & Porttier not listed.
