- 1912 Annual Town Report: Robert L. Studley lives on Elm Street [sic Pine] and owns a dwelling on Elm [sic Pine] Street (\$13,000), 14,000 sq. ft. of land on Croton Street (\$975), 13,550 sq. ft. of land on Pine Street (\$950), and 6775 sq. ft. of land on Pine Street (\$500).
